### **Industry Liaison committee**

**Frequency of meeting:** Committee will meet every 3 months. The minutes of meeting are required to be submitted to IQAC Periodically.

#### **Roles and Responsibilities:**

4. To motivate staff to apply for extension and outreach activity.
5. To create MoUs for extension and outreach activities carried out in collaboration with National and International agencies, Industry, the community, Government and Non-Government organizations engaging NSS/NCC/Red Cross/YRC/Institutional clubs etc. during the last five years.
6. To identify resource agencies for workshops/seminars conducted on Intellectual Property Rights (IPR) Research methodology, Good Clinical, Laboratory, Pharmacy and Collection practices, writing for Research Grants and Industry-Academia Collaborations.
7. To tie up with neighborhood community in terms of education, environmental issues like Swachh Bharat, health and hygiene awareness and socio-economic development issues for Institutional social responsibility activities.
8. To identify and do MoUs with institutes/ agencies for Collaborative activities for research, faculty exchange, student exchange/ Industry-internship.
9. To coordinate with the Research Promotion Committee for their requirement for collaboration, grants and publications.
