11. Take regular feedback from UG, PG students and faculties to identify problems faced by them for conduct and publication of research.
12. Discuss feedback in committee meeting and suggest effective solution to remove any roadblocks in conduct and publication of research.

**Frequency of meeting:** Committee will meet every 3 months. The minutes of meeting are required to be submitted to IQAC Periodically.
